





## Code of Conduct Policy

Saugeen Golf Club is committed to providing a respectful, welcoming, inclusive and safe recreational environment for our members, guests and staff. Our goal is to ensure behaviors exhibited while on the premises that respect the rights of all. It is the responsibility of everyone to abide by the Code of Conduct in order to foster a healthy culture aligned with the core values of Saugeen Golf Club.

### Membership Responsibilities

By applying for and accepting membership at Saugeen Golf Club, every member is agreeing to the following:

1. To respect and adhere to Saugeen Golf Course Code of Conduct, governance by-laws/policies and all local, provincial and federal laws.
2. To welcome new members and guests with respect, friendliness and support.
3. To act as an ambassador for Saugeen Golf Club while at the golf club and while representing SGC at club sanctioned events.

### Standards and Expectations of Player Conduct

All members and guests, whether playing golf or using other amenities, are expected to abide fully by the Code of Conduct while on premises. To meet the standards and expectations of the Code of Conduct, all members and guests shall:

1. Behave in a manner that is reflective of the personal integrity and respect governed by the Rules of Golf where it is written that we are responsible for enforcing rules upon ourselves with honesty, integrity and good sportsmanship.
2. Act in a manner free of discrimination or any form of harassing behaviour to fellow golfers, visitors or staff. This includes, but is not limited to sexual harassment, sexual assault, verbal abuse/assault, physical harassment and abuse and indecent exposure.
3. Respectfully use the golf course, amenities and facilities and repair any damage caused by play (ball marks, divot, etc.).
4. Abide by all local, provincial and national laws and regulations.
5. Comply with the dress code of Saugeen Golf Club.
6. Respect the game of golf, by adhering to general and local rules while demonstrating the principles of golf etiquette with other players.
7. Consume alcohol and all other legal substances responsibly.
8. Refrain from bringing outside alcohol, illegal or banned substances onto the property.
9. Report incidents in a timely manner to management that are believed to be in non-compliance with the code of conduct, club policies and local, provincial and federal legislation.

Members and Guests who are found to be in violation of the Code of Conduct may be subject to disciplinary actions as determined by Management. The extent of punishment will be advised and governed by the guidelines of the Discipline Policy.

## **Refund of Membership Fees Policy**

If a member passes away prior to June 1<sup>st</sup> of a year for which they have paid membership fees, then upon written request made to the Board of Directors by that deceased member's estate, the Board of Directors will refund the membership that has been paid by that member for the year. (Provide proof of death is submitted, the Board of Directors may delegate this authority to the General Manager.) Consideration will also be given by the Board of Directors to any request by the spouse of such deceased member, who has also paid a membership fee for that year, for a refund of their membership fees as well.

Saugeen Golf Club membership includes refund protection for paid up members up to July 31, 2024. This protection is rare in the golf business and reflects the value we place on having a long-term relationship with our members. If due to injury or sickness, a member is unable to golf for the balance of the golf season, the club will refund a portion of club dues, cart and trail fees but not any other fees. The amount of refund is based on calendar dates. A schedule of dates will be published annually as will the associated refund rate for such refunds. During the golf season the General Manager will inform the Board of Directors of refunds paid.

### **Refund Schedule for 2024**

Refund request for deceased member prior to June 1<sup>st</sup>, 2024- full refund eligible

Refund request prior to April 30<sup>th</sup>, 2024 (cash refund or transfer to 2025) – full refund eligible.

Refund request May 1st to June 30th, 2024 (cash refund or transfer to 2025) – based on a pro-rated percentage calculation of how many days remain in the season divided by the number of days in the golf season.

Refund request after June 30<sup>th</sup>, 2024, and before August 1st, 2024 will be offered on following years membership based on a pro-rated percentage calculation of how many days remain in the season divided by the number of days in the golf season

Refund request after July 31st, 2024 – is not eligible for refund.

Note: early bird memberships for 2024 will be prorated

Also

Members are offered the option of transferring their playing privileges to another person instead of taking a refund at any time during 2024 season.

The member would be considered a fully paid-up member for certificate holder purposes but would have relinquished playing privileges.

Transfers can be done once during the season, are subject to notice with the general manager and are not reversible.



## **Membership Referral Program for 2024**

Our Membership Referral Program is for those members that assist in bringing new members to our golf club. When a new member for the 2024 season acknowledges that they have been referred by a current member, the said member will receive the following:

**\$ 50.00 Credit on Member Account for 2024 Season**  
**Per 7 Day Adult Member Referred**

**\$ 75.00 Credit on Member Account for 2024 Season**  
**Per Couple Member Referred**

Members referring new members will be asked to assist in introducing new members to Saugeen Golf Club. This will allow new members to feel welcome and provide them with a contact person.

Membership referrals will be paid at the end of May 2024 as a credit on member's account.
